Shivana Herbals, No.434, Madhakoil Street, Karpaga Vinayagar Avenue, Acharavakkam Road, Sembakkam, Kanchipuram District, Pin – 603108 has surrendered the product license of Yashata Bhasma which contains Zinc Sulfate and apart from that no license for the medicines which contains Zinc Sulfate and Apple Cider Vinegar were granted to them.

Under Rule 159 of the Drugs and Cosmetics Act, 1940 and the Drug Rules, 1945 the Product license issued for Yashata Bhasma is hereby cancelled with effect from 20.02.2025. M/s. Shivana Herbals is instructed to stop the production of Yashata Bhasma.
